	The following shall apply if the principal place of business of the Initial Insured, as designated on the Cover Pag of the above-captioned Master Policy (the "Policy"), is located in Florida. Capitalized terms not otherwise defin	

herein shall have the meaning set forth in such Master Policy.

Section 15

Section 15.1 (Arbitration) of the above-captioned Policy is hereby amended by deleting such section in its entirety and replacing it with the following:

Section 15.1 - Arbitration

The Company and the Initial Insured or Servicer, as the case may be, agree that they will use their best efforts to resolve any disagreements arising under this Policy between themselves, including escalation procedures necessary to ensuring good faith communications between the parties. Should such efforts fail, any controversy or dispute, including any Claim made hereunder, <u>may</u>, upon agreement by the Insured and the Company, voluntarily be settled by submitting to arbitration in accordance with the rules of the American Arbitration Association in effect as of the date the agreement to arbitrate is made. The arbitration shall be held at a time and place agreed upon by the parties or, in the absence of such agreement and at the option of the Insured, in the capital of the state in which the Insured's principal place of business is located, or in the city nearest to the Insured's principal place of business in which the American Arbitration Association maintains an office. The arbitrator(s) shall be neutral person(s) selected from the American Arbitration Association's National Panel of Arbitrators. If possible, the arbitrator(s) shall be familiar with the mortgage lending or mortgage insurance business. Any proposed Arbitrator may be disqualified during the selection process, at the option of any party to the arbitration, if they are, or during the previous two years have been, an employee, officer, director or consultant of any mortgage insurer, or any entity engaged in the Origination, purchase, sale or servicing of mortgage loans or mortgage-backed securities, or of any Person that is an affiliate of such an insurer or entity.

Section 15.3(b) (State Specific Limitations) of the above-captioned Policy is hereby amended by the addition of the following provision:

Section 15.3(b) - State Specific Limitations

Florida: The 2-year period described in paragraph (a) of this Section 15.3 (Limitation of Actions) shall be extended to 5 years.
